**Invitation for Bids for the
Construction of Devasthan Park**

1. The Government of Nepal [GoN] has allocated funds towards the cost of Construction of Devasthan Park and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Devasthan Park** (Contract No: **DMO/NCB/WORKS/2077/78-23**). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Dhulikhel Municipality Office invites electronic bids from eligible bidders for the construction of Construction of Devasthan Park under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
Only eligible bidders with the following key qualifications should participate in this bidding:
 - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 107,600,000.00**
 - Minimum Work experience of similar size and nature: **at least One (1) RCC framed Building and One (1) Road construction works; contracts within last ten (10) years, each with value of at least NRs. 57,500,000.00**
3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Dhulikhel Municipality Office or may visit PPMO e-GP system www.bolpatra.gov.np/egg or may visit www.dhulikhelmun.gov.np
4. Bidder should submit their bid electronically only and may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egg. Bidders, submitting their bid electronically, should deposit the cost **NRs. 10,000.00** of bidding document till **29-07-2021, 12:00 hrs** in the Project's Rajaswa (revenue) account as specified below:

5. Pre-bid meeting shall be held at Dhulikhel Municipality Office at **18-07-2021 14:00Hrs**
6. Electronic bids must be submitted to the Dhulikhel Municipality Office through PPMO's e-GP system www.bolpatra.gov.np/egg on or before **29-07-2021 at 12:00Hrs**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' office Dhulikhel Municipality Office representatives who choose to attend at **29-07-2021 at 13:00 Hrs** at the office of Dhulikhel Municipality Office. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 2,140,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason whatsoever.
