1. *The Government of Nepal has allocated funds towards the cost of Construction of road from Ward no 2 office to Khatrigaun and Chapleti to Khatrigaun, ward no 2 and intends to apply part of the funds to cover eligible payments under the Contract for DMO/NCB/WORKS/2083/84/02. Bidding is open to all eligible as per Section V of bidding document.*
2. *Dhulikhel Municipality, Kavrepalanchok invites electronic bids from eligible bidders for the Construction of road from Ward no 2 office to Khatrigaun and Chapleti to Khatrigaun, ward no 2 under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.*

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 3,33,90,000 (Three crore thirty-three lakh ninety thousand rupees only)**
 - Minimum Work experience of similar size and nature: Participation as Prime contractor, management contractor, or subcontractor, within the last ten (10) years with a value of at least **NRs. 89,04,000 (Eighty-nine lakh four thousand rupees only)**, that have been successfully or are substantially completed and that are similar to the proposed works.
3. Bidder who chooses to submit their bid electronically, Bidders are required to submit two separate bid response documents, one containing (i) the Technical Bid and the other (ii) the Price Bid, as per the provision of ITB 21 of the Bidding Document.

 6. Pre-bid meeting shall be held at **Office Hall of Dhulikhel Municipality, Kavrepalanchok at 2083/05/16 at 13:00 hrs.**
 7. Electronic bids must be submitted to the office of **Dhulikhel Municipality, Kavrepalanchok** through PPMO's e-GP system www.bolpatra.gov.np/egp on or before **12:00 hrs** on **2083/05/25**. Bids received after this deadline will be rejected.
 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2083/05/25 at 12:30 hrs** at the office of **Dhulikhel Municipality, Kavrepalanchok**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs. 556500** which shall be valid for 30 days beyond the validity period of the bid (**2083/09/23**).
 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.

Sealed Quotations shall be opened in the presence of Bidders' representatives who choose to attend at 27-08-2026 12:30 hours at the office of Dhulikhel Municipality, Dhulikhel, Kavre, Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of NRs.50000 which shall be valid for 30 days beyond the validity period of the bid i.e 75 days.
